Prouty Beach & Campground is owned by the City of Newport and managed by the Newport Parks & Recreation Department. We reserve the right to refuse our services to anyone and will not be responsible for losses of any kind. If you decide to leave after 90 days of camping, we reserve the right to rent your site, without any refund.

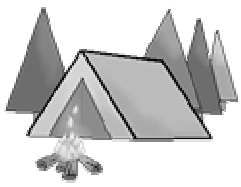
The campground will open on May 7, 2010 and closes October 11, 2010. **Seasonal rates are \$1,140 for Newport City residents and \$1,240 for non-Newport City residents.** First deposits of \$200 are due October 4, 2009, second deposits of \$325 are due by April 1, 2010 and final payment is due June 11, 2010. *No post dated checks will be accepted and a 1 1/2% late charge will be applied per month for late payments.*

In order to ensure proper site placement, we have implemented a new strategy to meet your needs. If a camper does not pay the first deposit by the deadline, their current site will no longer be saved. Instead it will be available to the person with the most seniority that expresses interest in the site. Open site #'s will be sent out via email to all seasonal campers, who then have the opportunity to declare interest in the open sites. Campers will have 5 days to respond to that email, if no response is received, we will assume you are not interested in the open sites. **Be sure to carefully fill out the seasonal application and meet all deadlines.**
